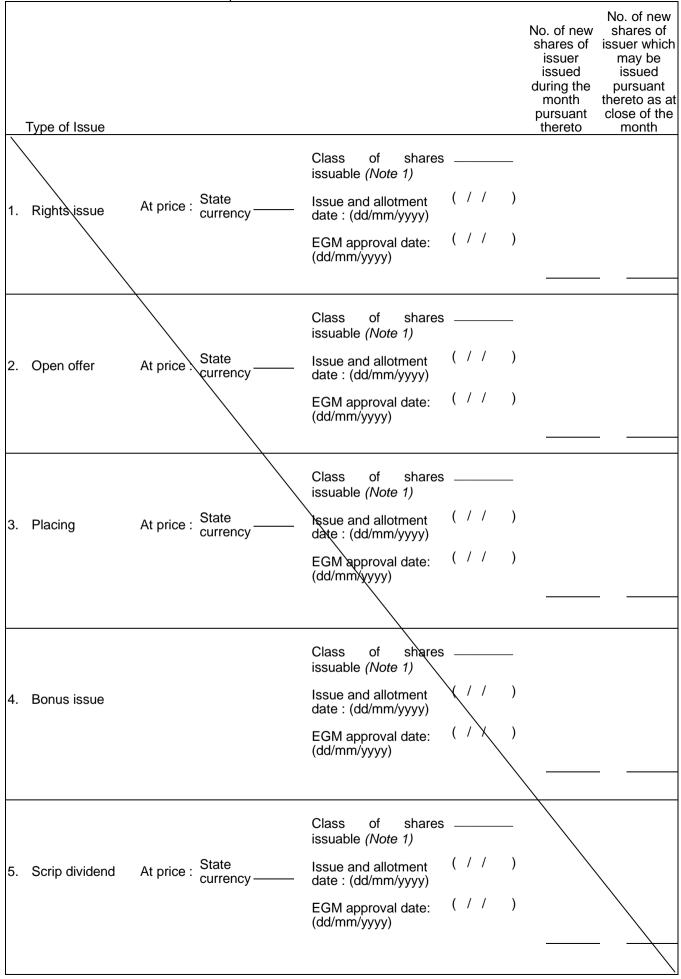

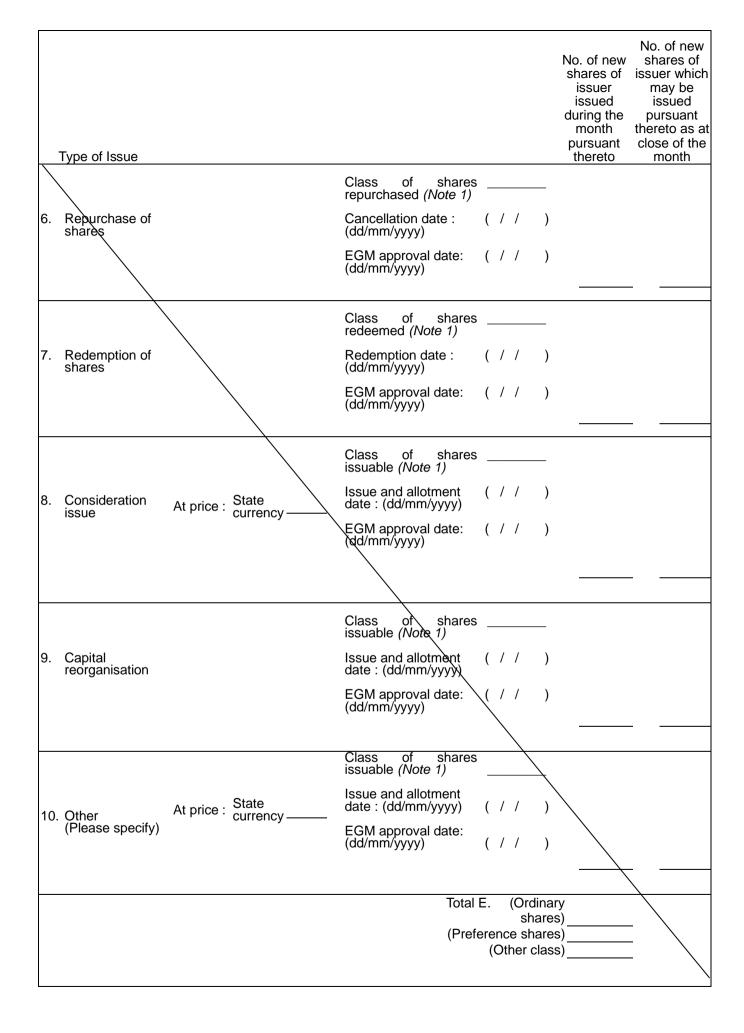

Where the issuer has already made the relevant confirmations in a return published under rule 13.25A in relation to the securities issued, no further confirmation is required to be made in this return.

  - the securities are of the same nominal value with the same amount called up or paid up;
